Subject: Resolution to Amend By-Laws Regarding Employment Policy

BE IT RESOLVED that, effectively immediately, the University at Buffalo Student Association Inc. ("SA") By-Laws be amended, such that the following text is added as the new Section 5.02(e)(iv), without quotes:

"The President and Treasurer may, by joint act, set and amend lawful employment policy(ies) for SA staff. Such policy(ies) may not conflict with employment policy(ies) adopted by the Senate or Executive Committee that are, by their terms, not amendable in such manner."

AND BE IT RESOLVED that, effective May 16, 2025 at 12:01 AM, the newly-created Section 5.02(e)(iv) of the SA By-Laws shall be renumbered to Section 5.02(g)(iv).
