Finance Committee Resolution - 2022-2023 - 1

Subject: Resolution to Set Club Budget Formula

Submitted by: Alana Lesczynski Treasurer

- 1. A Club that did not submit a budget packet on time will receive a \$0.00 budget.
- 2. A club's requested budget will be reduced to the lower of: (a) the total amount requested by the club or (b) the total itemized expenditures in their budget packet.
- 3. Cross off amount requested for line items that are not allowed under SA or SUNY Policy, that are not reasonably feasible, or that are denied due to reasonable concerns about insurability or liability.
- 4. Reduce anything related to merchandise sales by 50%
- 5. No money will be allocated for publications or digital media.
- 6. Tiers
 - A club may not receive more than the maximum budget allowed for their eligible tier under the budget policy.
 - Clubs must meet the requirements for the tier they have requested a budget for in order to change their current tier as per the budget policy.
 - Clubs who do not meet the requirements for their respective Tier will, during the budgeting process, be eligible for, at most, funding in the Tier that they did complete the requirements for as per the budget policy.
 - Clubs can only move up one tier at a time.
- 7. Maximum budget for any club is \$50,000 (before any percentage reduction described below).
- 8. Funds allocated to all clubs in total to be equal to or below \$720,000.00.
- 9. The finance committee may apply a percentage reduction to the final budget of all clubs if necessary or desirable to reduce the total amount allocated to clubs; the percentage reduction must be the same for all clubs in a tier, but the percentage may vary by tier.
- 10. Any appeals made by clubs may only be based on procedural error, inaccurate application of the above criteria or math pertaining to the relevant club, or violation of law.
