Resolution - Resolution - 2025-2026 - E#7

Subject: Resolution to Grant More Money to Clubs in the 2026-2027 SA Budget

Requested by: Laron Gresham Fomby, *Treasurer*

WHEREAS, on or about April 22, 2026, the University at Buffalo Student Association Inc. ("SA") Senate approved the SA Treasurer Proposed Budget for the 2026-2027 fiscal year (the "2026-2027 SA Budget"); and

WHEREAS, pursuant to Section 4.02(c)(iii)(1) of the SA By-Laws, the Executive Committee may approve budgetary changes if it is outside of the UB Fall and Spring Semester; and

WHEREAS, it is currently outside of the UB Fall and Spring Semester; and

WHEREAS, the following budgetary changes are in the best interest of SA and UB undergraduate students, affect the total amount of funding for all SA clubs combined, and no SA Club will receive any less money as a result of this resolution than they otherwise would have; and

WHEREAS, consistent with the mandates of SA's By-Laws and the Club Budget Policy, SA is strictly prohibited from considering the viewpoint(s) held and/or expressed by any club, its officers, or its members when making club budget determinations; and in making this decision, SA has not considered the viewpoint(s) held and/or expressed by any club, its officers, or its members.

Now, therefore, BE IT RESOLVED that 2026-2027 SA Budget is modified as follows:

1. The amount of \$275,000.00 allocated for Bullsapalooza is reduced to \$25,000.00; and
2. The amount of \$850,000.00 allocated for Club Budgets is increased to \$1,100,000.00.

AND BE IT RESOLVED, for clarification purposes, that the separate allocation of \$50,000.00 for Bullsapalooza included in the 2026-2027 SA Budget is unaffected by this resolution.
