Subject: Resolution to Grant Club Appeals to Revoke Erroneous
Derecognition Letters

WHEREAS, due to two different separate typographical errors, the University at Buffalo Student Association Inc. (“SA”) UB Students for Information Technology club (“UBSIT”) and Pharmacology and Toxicology Club (“P&T”) were both erroneously notified that their club was derecognized on May 9, 2025 for failing to hold three on-campus events; now, therefore,

BE IT RESOLVED that, effective immediately, UBSIT’s appeal is granted, their May 9, 2025 notice of derecognition is revoked, and UBSIT’s status is restored to the status UBSIT would have held if UBSIT had not received the May 9, 2025 notice of derecognition; and

BE IT RESOLVED that, effective immediately, P&T’s appeal is granted, their May 9, 2025 notice of derecognition is revoked, and P&T’s status is restored to the status P&T would have held if P&T had not received the May 9, 2025 notice of derecognition.
