Annual Registration and Requirements for Recognition Policy be amended, such that the text under the "Phase Three" subheading under the "Timeline for Registration" heading is replaced in its entirety with the following text, without quotation marks:

"4. Deadline 4: Beginning after SA's new fiscal year opens on each August 1, each club shall gain access to its budget after it completes both Phases Two and Three."; and

**Subject:** Resolution to Amend the SA Inventory Policy

Requested by: Aisha Adam, SA President; Will Dong, SA Vice President for Clubs;

Jack Koscinski, SA Treasurer.

**BE IT RESOLVED** that the University at Buffalo Student Association Inc. ("SA") Inventory Policy be amended, such that:

1) The sixth paragraph be replaced with the following text, without quotation marks:

"In some instances, multi-year items will be no longer useful or due to normal wear and tear, obsolescence, and or breakage will happen. When this arises the club or department should, when possible, bring the item to the SA office to be reviewed and start the process for of repair or disposal. If the asset cannot be brought to the office, a club should schedule an appointment with the Finance Procurement Department so the item can be reviewed in a separate location. can go to the multi-year item for the review. Multi-year items can be sold for fair market value, traded for a replacement, donated, or disposed of with the approval of the SA Treasurer and President.";

2) The seventh paragraph be replaced with the following text, without quotation marks:

"If a club or department wishes to dispose of a multi-year item, they must contact SA to start the process of disposal or replacement."; and

3) The following text be added as a new eighth paragraph, without quotation marks:

"SA may also maintain certain items that may be used and borrowed by SA clubs and SA staff for SA's own programming (the "Reservable Items"). Reservable Items may be booked by clubs and SA staff on a first-come, first-served basis. The SA Treasurer may set, and from time-to-time change, time limitations for how long a Reservable Item may be booked, which shall be the same for all clubs, but may vary from item to item. If a club does not return a Reservable Item on time or returns it damaged, then the SA Treasurer may charge the club for its replacement cost, ban

the club from using and borrowing Reservable Items for up to six months, or both. Reservable Items may only be used for approved SA programming or SA club events with an approved UBLinked event. When a club borrows a Reservable Item, only the club's President, Vice President, Treasurer, or Secretary may reserve and pick up the item. Reservable Items must be returned directly to designated SA staff during SA office hours. Clubs must immediately report any damage to Reservable Items to SA staff."; and

**BE IT RESOLVED** that: this Resolution is effective immediately; any underlining in this Resolution is for emphasis only and shall not be included in the text of the amended policy; and any strike-throughs of text in this Resolution are for emphasis only and any struck-through text shall not be included in the text of the amended policy.



Resolution - 2025-2026 - E#5

Subject: Resolution to Amend the SA Encumbrance and Expenditure Policy Requested by: Aisha Adam, SA President; Will Dong, SA Vice President for Clubs;

Jack Koscinski, SA Treasurer.

**BE IT RESOLVED** that the University at Buffalo Student Association Inc. Encumbrance and Expenditure Policy be amended, such that the following is added above the "Exceptions to Pre-Approval of an Expense" heading:

- 1) a new heading is inserted, consisting of the following text without quotation marks: "Use of Items Associated with Certain Vendors"; and
- 2) under such new heading, the following text is inserted, without quotation marks:

"SA may utilize methods of doing business with vendors that require the use of a certain physical item(s) during a transaction. For example and without limitation, SA may require a club to utilize a card issued by a vendor.

The SA Treasurer may set, and from time-to-time change, time limitations for how long such an item may be used, which shall be the same for all clubs, but may vary from item to item. When a club utilizes such an item, only the club's President, Vice President, Treasurer, or Secretary may pick up the item. Clubs must return such items directly to designated SA staff during SA office hours and must immediately report any loss of or damage to such items to SA staff. A club's failure to return such an item in accordance with the applicable time limitation shall constitute a violation of this policy." and



Resolution - 2025-2026 - E#6

Subject: Resolution to Amend the SA Supplemental Funding Policy

Requested by: Aisha Adam, SA President; Will Dong, SA Vice President for Clubs;

Jack Koscinski, SA Treasurer.

WHEREAS, the University at Buffalo Student Association Inc. ("SA") seeks to improve the criteria used for awarding supplemental funding under the SA Supplemental Funding Policy, consistent with what is allowed under section 7.04 of the SA By-Laws, in order to increase the overall opportunity for all SA clubs to utilize supplemental funding; and

WHEREAS, SA seeks to amend such policy as soon as possible, so as to allow the SA Treasurer to begin accepting applications for supplemental funding as soon as possible and to allow the new criteria to be consistent for the academic year; now, therefore,

**BE IT RESOLVED** that the SA Supplemental Funding Policy be amended, such that, within the "Types of Supplemental Funding" heading:

- 1) in the second full paragraph under such heading, the text "evenly divided for fall and spring semester distribution" is replaced with "divided, with two-thirds allocated for distribution during the fall semester and one-third allocated for distribution during the spring semester,";
- 2) under the "Travel/Conferences" subheading, the following text without quotation marks is added as the new second sentence in the first full paragraph: "A club may not receive more than \$5,000 in Travel/Conferences supplemental funding per academic year in total."; and
- 3) under the "Events" subheading, the text "\$2,000" is replaced with "\$4,000"; and
