**Subject:** Resolution to Amend the SA Annual Registration and Requirements for Recognition Policy

**Requested by:** Aisha Adam, SA President; Jack Koscinski, SA Treasurer.

**BE IT RESOLVED** that the University at Buffalo Student Association Inc. Annual Registration and Requirements for Recognition Policy be amended, such that, under the “Timeline for Registration” heading:

- 1) the following text, without quotation marks, is deleted: “4. Deadline 4: To participate in Campus Fest clubs must complete phase one and phase two before July 15<sup>th</sup>.”; and
- 2) under the Phase Three subheading, item 5 (as currently numbered) is renumbered as item 4, and “Deadline 5” is changed to “Deadline 4”; and
